- 1. For AMC a separate contract will be finalized and contract agreement executed between NMRCL and Contractor keeping in view the accepted AMC rates etc. in this Bid before the expiry of Defect Liability Period and well within the expiry of Performance Bank Guarantee. The performance security for AMC contract shall be of 10% value of AMC cost as per Cost Centre I.
- 2. The contract shall be comprehensive in nature wherein preventive as well as break down maintenance of above equipments to be covered under this contract including the arrangement of office set-up, spares, tools, consumables, technical expertise,

communication system and manpower. The scope of maintenance contract shall include: (a) Preventive maintenance of equipment as per maintenance schedule prescribed by the supplier and (b) Breakdown Maintenance. During AMC period, the RAM requirements and DLP obligations including penalty as provided in the Bidding Documents shall generally apply.

- 3. In case of failure of any of the equipment covered under maintenance contract, it shall be repaired or replaced within reasonable time not exceeding one week from the day of reporting by NMRCL.
- 4. Rates of AMC are to be quoted in Indian Rupees only and no Price Variation is permitted on AMC charges. It may be noted that only Service Tax is applicable on AMC charges.
- 5. Contractor shall submit detailed plan for comprehensive AMC at least 12 months prior to expiry of Defect Liability Period.
- 6. For the purpose of working out Cash flow only, the beginning of the AMC shall be considered as end of DLP.
- 7. Payment towards the AMC shall be released as per payment clause , by the Employer.
- 8. The Contractor shall handover the equipment under AMC including rotating spares in a working condition to the Employer after expiry of AMC period.
